RESOLUTION NO. 88-122

AUTHORIZING THE SELECTION AND APPROPRIATION OF RIGHTS OF-WAY AND EASEMENTS OVER, ACROSS AND THROUGH PROPERTY COMMONLY KNOWN AS THE AIRPORT ROAD AREA, LOCATED IN HOPEWELL TOWNSHIP, BEAVER COUNTY, PENNSYLVANIA, FOR THE PURPOSE OF EXTENDING A SANITARY SEWER LINE, AND FURTHER AUTHORIZING THE FILING OF A DECLARATION OF TAKING AND ALL NECESSARY ACTION FOR THE ACQUISITION OF SAID PROPERTY.

WHEREAS, the Township of Hopewell, Beaver County, Pennsylvania, pursuant to an agreement adopted and entered into on the 28th day of September, 1987, with the United States Department of Labor's Mine Safety and Health Administration is about to proceed with all necessary action to provide sanitary sewer service to properties located within Hopewell Township; and

WHEREAS, in order to carry out the terms of the said agreement, it is necessary that the Township of Hopewell acquire a right-of-way and easement of land necessary to provide said sanitary sewer service; and

WHEREAS, the Township has been unable to agree with the owners of the properties to be acquired as to price or damages to be paid; and

WHEREAS, in accordance with the First Class Township Code, being the Act of June 24, 1931, Pub.L.No. 1206, art. I § 101, as amended at 53 P.S. § 56901, the Township is authorized to acquire title to said properties through Eminent Domain proceedings.

NOW THEREFORE, BE IT RESOLVED, that the Township of Hopewell, Beaver County, Pennsylvania; in accordance with authority conferred by law, may select and appropriate a right-of-way and easement over, across and through

property situate in the Township of Hopewell for the purposes of extending sanitary sewer service to the facility of the United States Department of Labor's Mine Safety and Health Administration located on Airport Road.
