Dear Members of the Board:

The Beaver County Corporation for Economic Development (CED) is charged with facilitating and promoting industrial expansion and job creation in Beaver County. Part of CED's responsibilities include marketing and promoting Beaver County to prospective businesses.

Toward that end, CED has developed the county's first professional marketing and promotion program. This program includes regional, national, and international advertising in trade journals and publications, a video promoting Beaver County as business location, and a promotional package that offers background on the county. A copy of that package is attached for your examination.

Marketing and promotion financing comes from county government, private corporate contributions, and funding from the state's Industrial Development Assistance Program. The Board of Beaver County Commissioners has designated CED to be the recipient of funds under Industrial Development Assistance Program for Beaver County. The annual amount of the grant is approximately \$8500, depending upon the amount the state legislature appropriates and the number of counties that participate. This year's appropriation to Beaver County is \$8702.

In order to continue to qualify for funding, municipalities representing over 51% of Beaver County's population must pass a resolution concurring with the County Commissioners designation of CED as the recipient agency. We have attached a draft resolution for your consideration. Adoption of the resolution will allow CED to maintain a very important funding source for its marketing and promotion efforts.

CED must forward the required number of resolutions to the Pennsylvania Department of Commerce no later than the first week of May. If an appropriate number of resolutions are not received by that time, the funds will be allocated to another county. Hopewell Township Board of Commissioners April 3, 1989 Page 2
