

Resolution No. 110

A RESOLUTION OF THE TOWNSHIP OF HOPEWELL
ACKNOWLEDGING THE ADOPTION OF A CORRECTIVE ACTION
PLAN BY THE MUNICIPAL WATER AUTHORITY OF
ALIQUIPPA AND EXPRESSING THE TOWNSHIP'S INTENT TO
FULLY COOPERATE IN THE IMPLEMENTATION OF SAID
PLAN.

WHEREAS, the Municipal Water Authority of Aliquippa is presently subject to restrictions to grant new tap connections imposed by the Pennsylvania Department of Environmental Resources on account of hydraulic overloading; and

WHEREAS, the Pennsylvania Department of Environmental Resources has required the Municipal Water Authority of Aliquippa to prepare a Corrective Action Plan (hereinafter referred to as the "Plan") to address the aforementioned problem and to proceed with the elimination of excess inflow and infiltration. A copy of said "Plan" has been provided to the Township and is incorporated herein by reference; and

WHEREAS, various residents of the Township of Hopewell are connected to and serviced by the sewage treatment system of the Municipal Water Authority of Aliquippa; and

WHEREAS, the Municipal Water Authority of Aliquippa has requested that the Township of Hopewell agree to identify, and if necessary correct any problems of inflow and infiltration that may be emanating within the boundaries of the Township of Hopewell and which may be contributing to excess inflow and infiltration; and

WHEREAS, said participation by Hopewell Township is essential to the approval of the "Plan" by the Pennsylvania Department of Environmental Resources; and

WHEREAS, the Township of Hopewell desires to cooperate in the implementation of said "Plan" by identifying, and if necessary correcting, any problems of inflow and infiltration that may be emanating from within the boundaries of the Township of Hopewell and which may be contributing to excess inflow and infiltration into the sewage system of the Municipal Water Authority of Aliquippa; and

WHEREAS, the Township of Hopewell intends on undertaking such cooperation in the scheduling of the implementation of said "Plan" within a reasonable time after the Municipal Water Authority of Aliquippa advises the Township of the Authority's schedule with respect to the Authority's implementation of the "Plan".

NOW THEREFORE, BE IT RESOLVED, that the Board of Commissioners of the Township of Hopewell, a Municipal Corporation situated in Beaver County, Pennsylvania, under the First Class Code, and it is hereby RESOLVED that:

1. The Township of Hopewell acknowledges the adoption of the Corrective Action Plan by the Municipal Water Authority of Aliquippa and hereby agrees to assist in the implementation of said "Plan" as set forth in the body of the within Resolution.
