## RESOLUTION NO.: 93-111

A RESOLUTION OF THE TOWNSHIP OF HOPEWELL AUTHORIZING THE ACQUISITION BY CONDEMNATION OF RIGHTS OF WAY AND EASEMENTS ACROSS AND THROUGH PROPERTY LOCATED IN HOPEWELL TOWNSHIP, BEAVER COUNTY, PENNSYLVANIA, FOR THE PURPOSE OF CONSTRUCTING A SANITARY SEWER SYSTEM AND APPURTENANCES THERETO AND FURTHER AUTHORIZING THE FILING OF A DECLARATION OF TAKING AND ALL NECESSARY ACTION FOR THE ACQUISITION OF SAID PROPERTY.

WHEREAS, the Township of Hopewell has previously adopted plans to construct a sanitary sewer system to provide sewer service throughout the Woodlawn Park Area; and

WHEREAS, in order to provide sanitary sewer service to the Woodlawn Park area, it is necessary that the Township of Hopewell acquire rights-of-way and easements of land necessary to construct said system; and

WHEREAS, the Township has been unable to agree with several of the owners of properties to be acquired as to price or damages to be paid; and

WHEREAS, in accordance with the provisions of the Eminent Domain Code at 26 P.S. §1-101, as amended and the First Class Township Code at 53 P.S. § 56901, et. seq., the Township of Hopewell is authorized to acquire title to said properties for public purposes through Eminent Domain proceedings.

NOW THEREFORE, BE IT RESOLVED, that the Township of Hopewell, Beaver County, Pennsylvania, in accordance with authority conferred by law, may select and appropriate rights-of-way and easements over, across and through property situate in the Township of Hopewell for the purpose of constructing a sanitary sewer system.
