RESOLUTION NO. 96-113

A RESOLUTION OF THE BOARD OF COMMISSIONERS OF HOPEWELL
TOWNSHIP RESTRICTING TRAFFIC ON STONE QUARRY ROAD, HOPEWELL
TOWNSHIP, PENNSYLVANIA

WHEREAS, Stone Quarry Road, Hopewell Township, is a public road owned and maintained by the township of Hopewell; and

WHEREAS, the operation of heavy vehicles upon Stone Quarry Road, Hopewell Township, has caused and continues to cause severe damage to the road surface; and

WHEREAS, residents along Stone Quarry Road, Hopewell Township, are concerned that the further operation of heavy vehicles upon Stone Quarry Road will render the road incapable of sustaining any traffic; and

WHEREAS, Pursuant to the First Class Township Code Title 53 §57014 Pa. C.S.A. the Board of Commissioners of Hopewell Township deems it necessary for the protection of the public safety, because excessive and unusual conditions have rendered Stone Quarry Road unfit and unsafe for travel, that Stone Quarry Road be temporarily closed to all vehicles with the exception of light passenger vehicles, school buses and garbage trucks; and

WHEREAS, anyone illegally using Stone Quarry Road hereafter without the written consent of the Board of Commissioners of Hopewell Township shall be subject to a penalty of one hundred (\$100.00) dollars and the cost of prosecution per violation upon conviction thereof in a summary proceeding before a Justice of the Peace. In addition to these penalties, any violator shall also be subject to pay for any damage caused to Stone Quarry Road.

BE IT RESOLVED by the Board and it is HEREBY RESOLUTED AND ENACTED by authority of the same; Pursuant to the First Class Township Code Title 53 §57014 Pa. C.S.A. the Board of Commissioners of Hopewell Township deems it necessary for the protection of the public safety, because excessive and unusual conditions have rendered Stone Quarry Road unfit and unsafe for travel, that Stone Quarry Road be temporarily closed to all vehicles with the exception of light passenger vehicles, school buses and garbage trucks.

Anyone illegally using Stone Quarry Road hereafter without the written consent of the Board of Commissioners of Hopewell Township shall be subject to a penalty of one hundred (\$100.00) dollars and the cost of prosecution per violation upon conviction thereof in a summary proceeding before a Justice of the Peace. In addition to these penalties, any violator shall also be subject to pay for any damage caused to Stone Quarry Road.
