AUTHORIZING HOPEWELL TOWNSHIP AUTHORITY TO LAY, CONSTRUCT, MAINTAIN AND REPLACE SEWER LINES AND THE FIXTURES AND APPURTENANCES THEREOF IN THE FUBLIC THOROUGHPARES IN THE TOWNSHIP OF HOPEWELL

Hopewell, Beaver County, Pennsylvania that:

Section 1. Hopewell Township Authority is hereby granted the right, privilege, authority and franchise to lay, construct, maintain, repair and replace sewer lines and the fixtures and appurtenances thereof through, over and across the public roads in said Township for the purpose of conveying and transporting sewage.

Section 2. All such sewer lines shall be laid and constructed at such depth beneath the surface of said public roads and in such manner as not to interfere with the proper drainage and the occupancy of other utility facilities underlying said roads.

Section 3. It shall be the duty of Hopewell Township Authority to provide and saintain proper and adequate guards, barriers and lights, and it shall assume all risks and be liable for all damages by reason of any openings or excavations made by it in said public reads and by reason of any failure to properly fill any hole or trench made by it and maintain the surface disturbed in a safe condition.

Authority, after causing any opening or excavation to be made, to thoroughly and completely fill the same, puddling and remning so as to prevent any settling thereafter, and to replace the surface of the thoroughfare as it was before the opening and in the propergrade and with the same surface covering as the part of the thoroughfare adjoining the opening, without ridges or depressions,
