## RESOLUTION NO. 61-101

A Resolution of the Township of Hopewell, Beaver County, Pennsylvania, authorizing the conveyance and sale at private sale of Lots Nos. 27, 28 and 51 in the Davidson Heights Plan, Hopewell Township, Beaver County, Pennsylvania, recorded in the Recorder's Office of Beaver County, Pennsylvania, in Plan Book Vol. 5, pages 58 and 59.

WHEREAS, Michael Baker Jr., and Myrtle E. Baker, his wife, by a generous deed of gift dated November 13, 1959, recorded November 27, 1959 in Deed Book Vol. 768, page 383, granted and conveyed unto the Township of Hopewell a number of lots situate in the Davidson Heights Plan, Hopewell Township, Beaver County, Pennsylvania as recorded in Plan Book Vol. 5, pages 58 and 59, and
