

RESOLUTION NO. 62-105

BE IT RESOLVED that pursuant to the Act of Assembly 1947 P.L. 1145 as amended by the Act of 1949 P.L. 898 and amendments, that Township Ordinance No. 58-3 as amended, imposing a tax for general revenue purposes at the rate of 4/10 of one percent on salaries, wages, commissions and other compensation earned by residents of the Township of Hopewell, and on salaries, wages and commissions and other compensation earned by non-residents of the Township of Hopewell for work done or services performed or rendered in the Township of Hopewell and on the net profits earned from businesses, professions or other activities conducted by such residents, and on the net profits earned from businesses, professions or other activities conducted in the Township of Hopewell by non-residents; requiring the filing of returns and the giving of information by employers and those subject to the said tax; imposing on employers the duty of collecting the tax at source; providing for the administration and enforcement of the ordinance and imposing penalties for violation thereof; and conferring <sup>and</sup> the imposing powers and duties on the collector of Hopewell Township, has been reenacted by the Township of Hopewell, Beaver County, Pennsylvania, without substantial change for the fiscal year of 1963.
