## RESOLUTION 78-107

WHEREAS, on May 1, 1975, Lang Builders, Inc. (see D. B. Vol. 1041, page 6), conveyed all of Lot No. 122 and one foot of Lot No. 123 in the Barrett Plan as recorded in Plan Book Vol. 11, page 47, to Dr. Paul V. Tabita and Debroah A. Tabita, husband and wife, together with one story brick and aluminum siding dwelling house with an attached garage; and

WHEREAS, on the same date, Lang Builders, Inc. also conveyed the southerly 10 feet of Lot No. 121 adjoins Lot No. 122, same plan to the Tabitas; and

WHEREAS, said strip of land is 10 feet in width fronting on Wimpole Street, and runs along the entire length of northerly boundary of Lot No. 122 141.19 feet to the westerly line of Brodhead Road at which point it narrows to a width of 8.21 feet; (See print attached); and

WHEREAS, on November 7, 1977, the Planning Commission by letter informed Layden C. Sadecky, Attorney, that they have reviewed the matter and recommended approval of said subdivision to the Hopewell Township Board of Commissioners (See letter attached);
