## RESOLUTION 79-141

A RESOLUTION OF THE TOWNSHIP OF HOPEWELL, BEAVER COUNTY, PENNSYLVANIA, REQUESTING THE PENNSYLVANIA DEPARTMENT OF TRANSPORTATION TO MAKE CERTAIN IMPROVEMENTS TO THAT PORTION OF GOLF COURSE ROAD (L. R. 04072) LYING WITHIN THE TERRITORIAL LIMITS OF THE TOWNSHIP: AND AFTER SAID IMPROVEMENTS HAVE BEEN MADE, TO ABANDON SAID PORTION OF SAID ROAD FOR THE PURPOSE OF PERMITTING THE SAME TO BECOME PART OF THE TOWNSHIP HIGHWAY SYSTEM.

WHEREAS, Golf Course Road (L.R. 04072), a State highway lying in the Borough of Aliquippa, and the Townships of Hopewell and Center in Beaver County, Pennsylvania, is in disrepair and now presents a hazard to the traveling public; and

WHEREAS, in cooperation with the Board of Supervisors of the Township of Center, the Board of Commissioners has sought to cause the Pennsylvania Department of Transportation to improve and maintain the same as a State highway; and

WHEREAS, the Pennsylvania Department of Transportation does not have sufficient maintenance funds for the improvements required to be made to Golf Course Road; and

WHEREAS, the Pennsylvania Department of Transportation by letter dated November 19, 1979, the same annexed hereto and by reference made a part hereof, has advised the Townships of Hopewell and Center that it will upon proper request cause the required improvements to be made to Golf Course Road from a source other than its general maintenance budget if the Townships will consent to the Commonwealth's abandonment of said road as a State highway and the Townships will cause said road to be made part of their respective highway systems; and

WHEREAS, the required improvements to Golf Course Road compel the prompt attention of the local governing bodies in order to protect the traveling public from substantial personal injury and property loss;
