## RESOLUTION NO. 80-112

A RESOLUTION OF THE TOWNSHIP OF HOPEWELL, LOCATED IN BEAVER COUNTY, PENNSYLVANIA, APPROVING THE PETITION FOR AGREED ORDER AND THE PROPOSED ORDER OF COURT, IN THE FORM ATTACHED, PROVIDING FOR THE REVISION OF THE 1976, 1977, 1978, 1979 and 1980 REAL ESTATE ASSESSMENTS OF JONES & LAUGHLIN STEEL CORPORATION'S ALIQUIPPA WORKS PROPERTIES WITHIN THE BOROUGH OF ALIQUIPPA AND THE TOWNSHIP OF HOPEWELL; STIPULATING REFUNDS DUE THE TAXPAYER FROM THE SCHOOL FISTERIEF; AND PROVIDING FOR A COUNTY-WIDE REASSESSMENT OF ALL TAXABLE REAL ESTATE TO BE MADE AND TO BE TIMELY PLACED IN LAWFUL EFFECT FOR THE 1982 TAX YEAR.

BE IT RESOLVED by the Board of Commissioners of the Township of Hopewell located in Beaver County, Pennsylvania, AND IT IS HEREBY RESOLVED:

- 1. That the Petition for Agreed Order and proposed Order of Court providing for the revision of the 1976, 1977, 1978, 1979 and 1980 real estate assessments of Jones & Laughlin Steel Corporation's Aliquippa Works properties within the Borough of Aliquippa and the Township of Hopewell, stipulating refunds due the taxpayer from the Township of Hopewell, and providing for a county-wide reassessment of all taxable real estate to be made and to be timely placed in lawful effect for the 1982 tax year, a true and correct copy of which is attached hereto and, be reference made a part thereof, is hereby approved.
- 2. That following the approval of said Petition for Agreed Order and proposed Order of Court, in form substantially similar to that attached hereto, by the Jones & Laughlin Steel Corporation, the County of Beaver, the School District of the Borough of Aliquippa, and the Township of Hópewell, Keith R. McMillen, Esq., the Township's Solicitor, is hereby authorized to deliver a certified copy of this Resolution to the Court of Common Pleas of Beaver County and there, for and in behalf of the Township

of Hopewell, to introduce said Petition for Agreed Order and proposed Order of Court jointly with counsel for the aforesaid taxpayer and the taxing districts and to move the Court for adoption of the proposed Order of Court.
