RESOLUTION NO. 80-124, 1980

A RESOLUTION OF THE TOWNSHIP OF HOPEWELL SETTING FORTH A FEE SCHEDULE TO BE USED IN THE ADMINISTRATION OF HOPEWELL TOWNSHIP ORDINANCE 80-6 PERTAINING TO THE HOPEWELL COMMUNITY PARK.

WHEREAS, the Commissioners of the Township of Hopewell did enact Ordinance No. 80-6 pertaining to the establishment and regulation of the Hopewell Community Park, said Ordinance having been duly enacted at a public meeting on June 10, 1980; and,

WHEREAS, Section 2, Subsection (e) requires that a deposit and rental fee be levied to insure the expedient and efficient enforcement of said Ordinance, and,

WHEREAS, the said fee schedule relating to said deposits and rentals is to be established from time to time by Township Resolution in accordance with the provisions of Ordinance No. 80-6, Section 2, Subsection (e), and;

WHEREAS, the sole purpose of the deposit is to insure that the park remains free from litter and/or all other waste occasioned by the utilization of the park; and it being the desire of the Township Board of Commissioners that the park deposit shall be refunded once a determination has been made that the utilized area of the park is free from litter and/or waste occasioned by its use; and

WHEREAS, the sole purpose of the rental fee is to defray the costs incurred by the Township in connection with the administration and regulation of the park permits mandated by Ordinance No. 80-6
