A RESOLUTION OF THE TOWNSHIP OF HOPEWELL, COUNTY OF BEAVER, PENNSYLVANIA, APPROVING A MONTHLY SERVICE CHARGE RATE OF \$6.50 PER TOWNSHIP RESIDENTIAL USER TO BE LEVIED BY CENTRE-VIDEO, INC. PURSUANT TO AN EXISTING FRANCHISE AGREEMENT BETWEEN THE TOWNSHIP OF HOPEWELL AND CENTRE-VIDEO, INC.

WHEREAS, Centre-Video, Inc. is in the general business of providing cable television services to various municipalities, one of which is the Township of Hopewell; and

WHEREAS, Centre-Video, Inc. and the Township of Hopewell have previously entered into a "Franchise Agreement", the terms of which require that the Township Board of Commissioners approve any increase in the monthly service charges levied upon Township residents by Centre-Video, Inc.; and

WHEREAS, subsequent to a joint meeting attended by representatives of Centre-Video, Inc. and the Township Board of Commissioners, it is apparent that an increase in the monthly service charge levied upon residential users of the Township is both justified and needed so as to insure the continued cable television service and anticipated expansion of cable television service (as more fully set forth in an Addendum to the "Franchise Agreement") that is provided and will be provided to the resident subscribers of the Township of Hopewell by Centre-Video, Inc.; and

WHEREAS, the Township Board of Commissioners pursuant to a careful review and study of the Centre-Video, Inc. cable television franchise are desirous of approving a monthly subscribers rate to be set at \$6.50 (Six Dollars-Fifty Cents) per residential user; and

WHEREAS, the administration and applicability of the new monthly service charge will be in connection with the common meaning given to that

NOW THEREFORE, be it resolved that the Board of Commissioners of the Township of Hopewell, a Municipal Corporation, under the First Class Township Code, situated in Beaver County, Pennsylvania, hereby resolves:

1. The request of Centre-Video, Inc. to set a monthly service charge at the rate of \$6.50 (Six Dollars-Fifty Cents) per residential user is hereby approved.
