SECTION 2. That "structures" shall be deemed to include, without limitation, self-supporting or free standing signs designed for commercial advertising or business identification. The following signs, however, shall be exempt from the provisions of this Resolution:

- (a) signs advertising the sale or rental of property;
- (b) political signs;
- (c) signs erected by governmental agencies;
- (d) signs erected by non-profit charitable, educational or religious agencies, if erected upon premises owned by such agency.

SECTION 3. It is hereby declared that the intent of this Schedule is to defray the costs of administering the Zoning Ordinance and other regulatory Ordinances of the Township of Hopewell safeguarding persons and property.

SECTION 4. Any Resolution or any provision of any Resolution conflicting with the schedule of fees herein established is hereby repealed.
