RESOLUTION NO. 94-116 , 1984

A JOINT RESOLUTION OF THE TOWNSHIP OF HOPEWELL, BEAVER COUNTY, PENNSYLVANIA, AND THE HOPEWELL TOWNSHIP SEWER AUTHORITY, BEAVER COUNTY, PENNSYLVANIA, AUTHORIZING THE DISCONNECTION OF CERTAIN HOPEWELL TOWNSHIP RESIDENTS FROM SEWAGE SERVICE BY THE MUNICIPAL WATER AUTHORITY OF ALIQUIPPA AND THE CONNECTION OF THOSE RESIDENTS TO THE HOPEWELL TOWNSHIP SEWER SYSTEM

WHEREAS, the Township of Hopewell and the Hopewell Township Sewer

Authority have determined that it is not in the best interests of the Township

to continue to have a substantial number of Hopewell Township residents

serviced by the Municipal Water Authority of Aliquippa; and

WHEREAS, the Township of Hopewell and the Hopewell Township Sewer
Authority have determined the feasibility of disconnecting a substantial
portion of those Township residents presently being provided sanitary sewage
service by the Muncipal Water Authority and connecting those residents to
the Hopewell Township Sanitary Sewage System; and

WHEREAS, the Township of Hopewell has been advised that the Municipal Water Authority of Aliquippa anticipates the issue of a bond indebtedness in September of 1984 to finance certain capital improvements in connection with the upgrading and operation of the Municipal Water Authority of Aliquippa sewer facility, which improvements are to be fully completed at the end of 1985; and

WHEREAS, the Township of Hopewell and the Hopewell Township Sewer

Authority have notified the Municipal Water Authority of Aliquippa of

"Hopewell's" intention to disconnect approximately 600 Hopewell Township users

of the Municipal Water Authority's System so the Aliquippa Authority has the opportunity to make any adjustments and/or modifications it may deem appropriate in connection with its anticipated bond issue for capital improvements which issue is scheduled to be finalized in September of 1984; and

WHEREAS, the anticipated completion date of the transition of the 600 Hopewell Township residents from the Municipal Water Authority of Aliquippa Sewage System to the Hopewell Township Sewage System is June of 1985.

NOW THEREFORE, Be it resolved that the Board of Commissioners of the Township of Hopewell, a Municipal Corporation, under the First Class Township Code, situated in Beaver County, Pennsylvania, and it hereby resolves:

The Hopewell Township Engineer, N.I.R.A. Consulting Engineers of 950 Fifth Avenue, Coraopolis, PA is hereby authorized and directed to immediately undertake the necessary steps to effectuate the transfer of approximately 600 Hopewell Township residents located in the Davidson Heights Plan (Spring Street) presently connected to the Municipal Water Authority of Aliquippa Sewage facility and to be connected to the Hopewell Township Sewage facility.
