Renee Cameron, 5923 Victor Circle Hopewell Township PA

Ms. Cameron questioned the board about what actions/research were taken prior to the garbage bid. She stated it was her understanding that; Valley Waste is the only one that submitted a bid. She also asked when the bid went out and if the township researched automated service? Mr. Kusnir replied that we did not look in to automated because never anticipated such a dramatic increase. Mr. Yurcina stated that the bid was sent out in September.

Rick Paich, 2363 Sheffield Rd. Hopewell Township, PA

Mr. Paich asked what was the reason for the amendment of the bid, because the Twp.went from unlimited pickup to a 2 can limit. Mr. Kusnir said the reason for the change was to lower the price.

Mr. Paich asked if he has three 32 gallon cans will they pick that up? Mr. Yurcina stated the he believed so but would ask to make sure.

Sean Henry, 209 Kinney Dr. Hopewell Township, PA

Mr. Henry stated he talked to someone from Waste Management today and they told him they never had the opportunity to bid. He also talked to someone from Valley Waste and was told it was already a done deal.

Mr. Yurcina commented that Waste Management was here for the bid. Mr. Kusnir said they were here and had the ability to bid but chose not to and Valley Waste was incorrect saying that it is a done deal, as it is on the agenda tonight.

Joe Panzino, 210 Winchester Ave. Hopewell Township, PA

Mr. Panzino questioned if it was 2 cans/100 gallons a week or a month. Mr. Yurcina stated that it was 2 cans/100 gallons a week with one bulky item a month. Mr. Panzino asked if the township has considered providing financing to offset the costs for the residents? Mr. Kusnir replied, no, the township is not going to subsidize the rates..

Mr. Langenhahn Inquired if these price increases are comparable to other townships in the area? Mr. Yurcina replied yes, and Center Township was having their garbage bid opening at 7:00

Cynthia Scherer, 1106 Queens Mill Rd. Hopewell Township PA

Ms. Scherer stated she lives by herself and puts out one grocery store bag once a month and asked if there could there be a database for the senior citizens or single people that barely use a can or recycle? Mr. Kusnir replied we can ask the question if there is something we can do for our residents that do not generate that much waste.

Mark Cripe, 5303 Clearview Ave. Hopewell Township, PA

Mr. Cripe asked what happens with the extra garbage? Does it stay on the street? Mr. Kusnir replied you cannot put out more than what is prescribed. Mr. Yurcina stated there should be an option of buying bag tags if you are over the 100 gallon limit and will check on the price of the tags.

Melanie Kamicker, 1514 Gringo Rd. Hopewell Township, PA

Ms. Kamicker stated we are never going to get Waste Management back. Valley Waste is now the middleman for Waste Management. She asked how do we do away with current regulations and choose our own garbage company? She stated her mother who lives in Independence Township chooses her own provider and the fee was only increased by \$5. She would like to have to have the option to choose service as well. Mr. Jones explained under the current ordinance in the township there is one contract. However, this is something that could be looked at in the future.

James Robolino, 3179 Bradbury Dr. Hopewell Township, PA

Mr. Robolino heard that Waste Management did reach out to Hopewell and were told they couldn't make the requirements as they wanted limited service because of manpower. Mr. Kusnir confirmed we put out a bid and we communicated and advertised to all the large carriers. They were given the opportunity under the current bid description, to bid.

Ms. Smith was inquiring why Valley Waste is not providing garbage cans? Mr. Yurcina Confirmed it would have an additional cost.
