Mr. Bufalini stated our area has needed this type of facility for some time and would like to investigate the property further.

Mr. Kusnir questioned if any environmental issues would come into play at the location due to its past tenant. He also inquired about the cost of the property.

Mr. Christiana has not heard what price they will be asking for the property.

Mr. Yurcina stated the price will need to reflect the necessary work needed to cap the property prior any improvements.

The Commissioners will discuss the project further.

### Don Sawyer LK Land Surveying

Mr. Sawyer asked when the Board of Commissioners will review his plan that was recommended for approval.

Mr. Jones stated that since the Planning Commission approved the plan he will write it up and it would be presented at a Public Business Meeting. The timeline is approximately two weeks.

### Ethan Pletcher, 1022 Sweet Brier Dr., Hopewell Township, PA

Mr. Pletcher presented plans for his proposed Eagle Scout Project, building a floating dock at the far end of the lake at Hopewell Community Park.

The Commissioners and the Manager discussed the different plan options, mechanics, and maintenance of the floating dock. The company he will be using is American Muscle Docks. Once the engineer approves the plan the commissioner would like to move forward with the first option presented,

Mr. Kusnir asked about prior concerns voiced by Amy Kohar, 1007 Harvest Dr. regarding the fence adjacent to the baseball fields at Hopewell Elementary. Mr. Yurcina stated that he is still looking into pricing the pylons needed for the project.

Mr. Kusnir is concerned about the on-going issues and condition of a run-down property on Brodhead Rd. and asked where we are in correcting the violations as the owner has previously filed for bankruptcy.

Mr. Jones confirmed that Mr. Bates cited them, and they did not appeal making it a deemed violation. Mr. Kusnir voiced his frustration over the longevity of the problem.

Mr. Kusnir also discussed five-point intersection and the problems with folks pulling in and out of the businesses at the intersection. He would like to see a guiderail to direct customers. Mr. Yurcina stated his concerns how the guide rails would block access to the businesses for their customers and the repercussions from that action. Concerns with confusion of customers not aware of which lights to obey when pulling out of parking areas were voiced.
