We are requesting that the minor adjustments of approximately 11 manholes be incorporated into the Department's prime construction contract because we are inadequately staffed to perform these adjustments and it would be in the best interest of the Department to incorporate this work. The labor costs are estimated to be equal to or less than the material costs and the total relocation cost is estimated to be less than \$20,000.00.

We will supply all necessary material needed for these adjustments provided the Department pay for the labor required for these minor adjustments. It is understood by both parties that a non-reimbursement agreement for this work is required.
