



RESOLUTION 2018-18

A RESOLUTION OF THE TOWNSHIP OF HOPEWELL, BEAVER COUNTY, PENNSYLVANIA APPROVING THE ROBENSKI LOT CONSOLIDATION PLAN INVOLVING THE COMBINATION OF TWO (2) LOTS INTO ONE (1) LOT. LOT #106 (CONTAINING A SINGLE FAMILY RESIDENTIAL UNIT) AND LOT #107 (VACANT) (TAX PARCEL NO. 65-016-0302.000) IN THE SUNSET HILLS PLAN (PLAN BOOK VOLUME 4 PAGE 20, DEED BOOD VOLUME 1707 PAGE 68) ARE BEING COMBINED. THE NEWLY CREATED PARCEL WILL CONTAIN 17,800 S.F. (0.4086 ACRES)), IN ACCORDANCE WITH THE ZONING ORDINANCE AND SUBDIVISION AND LAND DEVELOPMENT ORDINANCE.

WHEREAS, on August 24th, 2018, an application was submitted to Hopewell Township by Alexander S. Robenski to consider the proposed lot consolidation plan, known as the Robenski Lot Consolidation Plan, seeking to combine two (2) lots into one (1) lot. Lot #106 (containing a single family residential unit) and Lot #107 (vacant) (Tax Parcel No. 65-016-0302.000) in the Sunset Hills Plan (Plan Book Volume 4 Page 20, Deed Book Volume 1707 Page 68) are being combined. The newly created Parcel will contain 17,800 S.F. (0.4086 Acres), and

WHEREAS, the Beaver County Planning Commission rendered its comments in a letter dated August 27th, 2018, and

WHEREAS, on September 18th, 2018, Marie Stratakis Hartman, P.E, Hopewell Township Manager/Engineer, issued a comment letter addressing the aforementioned plan citing technical modifications required in order to comport with Hopewell Township Ordinances, and

WHEREAS, on Thursday, September 20th, 2018, (correspondence dated October 22nd, 2018) the Hopewell Township Planning Commission recommended approval of the Robenski Lot Consolidation Plan contingent upon compliance with the comments in Hopewell Township Engineer's letter dated September 18th, 2018 and any comments received from the Beaver County Planning Commission, and

NOW, THEREFORE, BE IT RESOLVED that the Hopewell Township Board of Commissioners hereby approves the Robenski Lot Consolidation Plan conditioned upon the applicant fully complying with the comments contained in the Hopewell Township Engineer's letter dated September 18th, 2018 and the written recommendations of both the Beaver County Planning Commission and Hopewell Township Planning Commissions prior to recording the Plan with the Beaver County Recorder of Deeds.
