Vice President Joe Kusnir - wanted to discuss road projects, including Forge Drive and the material used beneath the surface. He asked HRG to elaborate on the type of material and the reasoning behind the 2.5-inch road depth.

HRG Response:

The material in question is a fabric layer used to bridge the old and new sections of the road. It is crack-resistant and helps stabilize the base, minimizing road movement. One of the main concerns in a Steel Town is the issue of "slag." "Slag" refers to waste material from the steel industry—some of which performs well, while other types expand and contract when wet, leading to cracking.

Hopewell Township's goal is to address many years of deferred road paving. This is why projects now include overlays, tar, chip, and seal methods. The road fabric helps prevent cracking and improves long-term durability.

Milling is performed based on the condition of each road—whether it's flat, concave, or needs directional adjustment. Typically, the milling depth averages around 2½ inches. After milling, a minimum of 1 inch of leveling material is applied to smooth and even the surface, which also improves drainage.

Yes, the fabric is used in conjunction with the 2%-inch to 1-inch scratch and leveling course. HRG noted they can measure and verify the tonnage applied but clarified that the township's contract specifies HRG's oversight is on an as-needed basis. Rather than paying engineers to watch the milling process, the township prefers to allocate funds directly to road repairs. The focus is on addressing real infrastructure issues rather than tracking milling quantities.

Commissioner, Barb Michna - asked if road opening permits are required, and who monitors or approves them.

Vice President, Joe Kusnir - responded that utilities such as Duquesne Light, Columbia Gas, and local water companies must coordinate those permits.

Township Manager, Jamie Yurcina - added that these companies must complete the required paperwork and pay linear fees based on the length of their excavation and the age of the road. He noted that sometimes water companies dig up recently paved roads without prior notice.

Commissioner, Barb Michna - then asked whether the township has contracts or bids documentation available if someone requests them.

Solicitor – Mike Jones Responded that anyone could have access to the bids if they have a Right to know request.

HRG confirmed that all such information is public record.
